- All business or other activity, for which the vendors have rented space, must be conducted within the designated booth space only! No distribution, canvassing, flyers, nor vending of any kind may be done by strolling through the festival.
- The sale of alcoholic beverages of any kind is strictly prohibited. Any failure to comply with these beverage rules may result in forfeiture of vending fees and expulsion from the event.
- Vendors must provide own tables, chairs, shade cover/tent, lights, cables etc.

- Booth space is provided to the company/organization stated on the booth application only. No sharing of space is allowed unless pre-approved.
